### CHANGES TO THE COMPOSITION OF THE BOARD OF DIRECTORS AND THE BOARD COMMITTEES

The Board of Directors ("**Board**") of Asian Micro Holdings Limited ("**Company**") wishes to announce the following changes to the composition of the Board and the Board Committees of the Company with effect from 16 January 2026:

1. Mr. Adrian Lim Ek Duen ("**Mr. Adrian Lim**") has been appointed as an Independent Director of the Company.

The Board considers Mr. Adrian Lim to be independent and following his appointment as the Company's Independent Director, Mr. Adrian Lim would be appointed as Chairman of the Audit Committee ("**AC**"), a member of the Nominating Committee ("**NC**") and the Remuneration Committee ("**RC**").

2. Ms. Toh Li Ping, Angela ("**Ms. Angela Toh**") has been appointed as an Independent Director of the Company.

The Board considers Ms. Angela Toh to be independent and following her appointment as the Company's Independent Director, Ms. Angela Toh would be appointed as Chairman of the NC and the RC, and a member of the AC.

3. Mr. Cheah Wee Teong ("**Mr. Cheah**"), the Non-Independent Non-Executive Chairman of the Company, will step down as Chairman of the Board and remain as a member of the AC, the NC and the RC.
4. Consequent to the above changes, Mr. Tan Wei Lee ("**Mr. Tan**") will be appointed as the Independent Non-Executive Chairman. He will step down as Chairman of the AC, the NC and the RC but remain as a member of the AC, the NC and the RC.

The details relating to the appointment/re-designation of Mr. Cheah, Mr. Tan, Mr. Adrian Lim and Ms. Angela Toh as required under Rule 704(6) of the Catalyst Rules are set out in separate announcements on the SGXNet.
